MOTION BY COUNCILMAN SCHLEMMER, SECOND BY COUNCILMAN HAYES: THAT THE TOWN OF ELLERY ADOPT THE PUBLIC FUNDS CERTIFIED RESOLUTION FOR ALL BANK ACCOUNTS REQUIRING SIGNATURES; TOWN CLERK, TAX COLLECTOR, GENERAL AND HIGHWAY ACCOUNTS, AS PRESENTED.

1. CHERYL JOHNSON, JENNIFER JOHNSON AND SONYA JOHNSON, ROUTE 430 – SPOKE SEPARATELY AND COLLECTIVELY ABOUT THE ATROCIOUS CONDITION OF THE CONDEMNED PROPERTY OWNED BY PATRICK LUCARIELLO. THEY ARE FACED WITH LOOKING AT THE MESS, SUFFERING BREAKINS ON THEIR PROPERTIES BY THE SQUATTERS AND HARRASSMENT FROM MR. LUCARIELLO.

THE BOARD AND TOWN ATTORNEY ASSURED THEM THAT EVERYTHING THAT CAN BE DONE IS BEING DONE AT THIS POINT AND HOPEFULLY WITH TOWN COURTS OPENING UP ON THE  $26^{TH}$  OF JULY MORE CAN BE DONE TO REMEDY THE SITUATION.

2. DEB MOORE, CHENEY DRIVE – ASKED FOR AN UPDATE ON THE TOWN OWNED RIGHT-OF-WAY IN THE CHENEY ALLOTMENT.

TOWN ATTORNEY ROBINSON NOTED THAT THE TOWN SUPERVISOR HAS TO FILE A CERTIFICATE OF ABANDONMENT FOR THE TOWN OWNED RIGHT-OF-WAY WITH THE COUNTY CLERK AND THEN THE RESIDENTS OF THE CHENEY ALLOTMENT ARE FREE TO COMMENCE EFFORTS TO BUY THE PROPERTY.

## LEGISLATOR'S REPORT

LEGISLATOR CHAGNON REPORTED THAT THE COUNTY ACCEPTED INCREASED NYS FUNDING FOR CAPITAL IMPROVEMENTS TO CHAUTAUQUA COUNTY'S ROADS AND BRIDGES, RECEIVING INCREASED CHIPS FUNDS OF \$1,588 K, INCREASED PAVE NY FUNDS OF \$595K, AND INCREASED EXTREME WEATHER RECOVERY FUNDS OF \$951K; ROLLED OVER LEASES OF 7 LIGHT TRUCKS FOR THE DEPARTMENT OF PUBLIC FACILITIES. THE TRUCKS WERE LEASED TWO YEARS AGO, AND THE TOTAL GAIN ON THE FOLLOVER WAS \$100K. IN ORDER TO CAPITALIZE ON THE CURRENT MARKET CONDITIONS AND TO ENSURE DELIVERY OF VEHICLES, THE COUNTY AUTHORIZED INCREASING THE EXISTING FLEET OF 16 LEASED VEHICLES UP TO 54 LEASED VEHICLES: THE COUNTY LEGISLATURE HAD PREVIOUSLY ESTABLISHED THE CHAUTAUOUA LAKE PROTECTION AND REHABILITATION AGENCY TO REVIEW AND RECOMMENT TO THE COUNTY LEGISLATURE WHETHER IT IS IN THE BEST INTEREST OF THE COUNTY TO CREATE A CHAUTAUQUA LAKE PROTECTION AND REHABILITATION DISTRICT PURSUANT TO ARTICLE 5-1 OF THE COUNTY LAW. A RESOLUTION WAS PASSED TO EXPAND THE MEMBERSHIP OF THE AGENCY TO INCLUDE AN ELECTED OFFICIAL FROM EACH OF THE TOWNS AND VILLAGES BORDERING CHAUTAUQUA LAKE; SALES TAX REVENUE RECEIVED THROUGH THE END OF JUNE WAS 23.67% GREATER THAN THE SAME PERIOD LAST YEAR.

IT WAS NOTED THAT COUNCILMAN HAYES WILL BE THE TOWN OF ELLERY CLPRA REPRESENTATIVE.

### **HIGHWAY SUPERINTENDENT'S REPORT**

HIGHWAY SUPERINTENDENT HALLBERG REPORTED THAT HIS DEPARTMENT HAS BEEN BUSY WORKING ON ALL THE PROJECTS NORMALLY TAKING PLACE THIS TIME OF YEAR.

## ATTORNEY'S REPORT

MR. ROBINSON NOTED THAT HE HAD THE NEW CONTRACT FOR ASSESSOR SERVICES WITH THE TOWNS OF CHAUTAUQUA AND NORTH HARMONY. THE CONTRACT TERMS HAVE NOT CHANGED AND THE TOWN OF ELLERY WILL AGAIN RECEIVE \$5,000.

MOTION BY COUNCILMAN HAYES, SECOND BY COUNCILMAN CRESANTI: THAT THE SUPERVISOR IS AUTHORIZED TO SIGN THE NEW CONTRACT FOR ASSESSOR SERVICES WITH THE TOWNS OF CHAUTAUQUA AND NORTH HARMONY.

MR. ROBINSON ALSO NOTED THAT THE TOWN WILL HAVE TO BEGIN TO THINK ABOUT OPTING OUT OF ALLOWING MARIJAUNA SALES, ON SITE CONSUMPTION LOCATIONS, ETC. OR ALLOWING IT IN SOME AREAS OF THE TOWN. HE URGED THE BOARD TO BEGIN THINKING ABOUT IT AND HE WILL HAVE MORE INFORMATION ABOUT IT AT NEXT MONTHS MEETING.

#### LAKE RELATED MATTERS

LAKE CONSULTANT, JIM WEHRFRITZ, NOTED THAT 2021 TOWN OF ELLERY HERBICIDE TREATMENT HAS COME TO AN END. 100 ACRES OF CURLY LEAF PONDWEED WAS TREATED WITH AQUATHOL-K, MAY 12, 13<sup>TH</sup>. 10 ACRES OF EURASIAN WATER MILFOIL WAS TREATED WITH PROCELLACOR EC, JUNE 10<sup>TH</sup>. 56 PERMITTED ACRES WERE DISALLOWED BY THE DEC ON THE DAY OF TREATMENT – NO WEEDS?! ALL WATER USE RESTRICTIONS WERE REMOVED AS OF JUNE 22<sup>ND</sup>. THERE WILL BE A MEETING ON JULY 20<sup>TH</sup> WITH SOLITUDE AND OTHERS TO REVIEW 2021 AND PLAN FOR 2022.

MR. WEHRFRITZ THEN TRUNED HIS ATTENTION TO REPORTING ON RECENT ACTIVITIES OF THE ALLIANCE. HE NOTED THAT THE RECENT ELECTIONS WERE INCONSISTENT WITH THE BY-LAWS -PIERRE (OUTGOING CHAIRMAN, AGREED TO UPGRADE PROCEDURES FOR 2022. BRUCE ERICKSON OF THE CLA IS THE NEW ALLIANCE BOARD CHAIRMAN. THERE WAS A PUBLIC BOARD MEETING TODAY PRIOR TO THE TOWN BOARD MEETING. THE TOWN OF ELLERY MUST DECIDE WHETHER TO REJOIN.

ALSO REPORTED BY MR. WEHRFRITZ WERE ACTIONS AT THE JULY 1ST MEETING OF CHAUTAUQUA LAKE PROTECTION AND REMEDIATION AGENCY. THE "PRIVILEGE OF THE FLOOR" WAS FIRST ON THE AGENDA BEFORE ANY PRESENTATIONS AND NO QUESTIONS/COMMENTS WERE ALLOWED AFTER WHICH SEEMS A BIT BACKWARDS. AN INFORMAL VOTE BY 60 ATTENDEES SHOWED A LARGE MAJORITY (80 PLUS %) SUPPORT COUNTY WIDE TAXATION. THE AGENCY AGREED TO ISSUE A RFP FOR A BROADER SCOPE OF WORK AFTER 3 ½ YEARS WITH HIGHLAND PLANNING. IN SUMMARY, MR. WEHRFRITZ REPORTED THAT DURING ONE-ON-ONE CONVERSATIONS WITH THE COUNTY ATTORNEY AND CLPRA BOARD CHAIRMAN HE FOUND OUT THAT THERE IS NO WRITTEN LEGAL OPINION SUPPORTING CLPRA'S "NEAR-LAKE" DISTRICT LIMIT AND ALSO "DISTRICT" CONCEPT PRECLUDES COUNTY-WIDE PROPERTY TAX LAKE FUNDING (DISTRICT CAN'T BE THE COUNTY), BUT THAT DOESN'T SEEM NECESSARILY SO.

IN CLOSING, MR. WEHRFRITZ NOTED THAT SUPERVISOR JOHNSON SIGNED THE MOU WITH NO-LITIGATION TERM CROSSED THROUGH.

### ALLIANCE MEMBERSHIP

MOTION BY COUNCILMAN HAYES, SECOND BY COUNCILMAN SCHLEMMER: THAT THE TOWN OF ELLERY RENEW ITS MEMBERSHIP (\$2,000.00) IN THE ALLIANCE FOR 7/1/2021 THROUGH 6/30/2022.
